The dispute was settled under President Richard Nixon who amended the Guadalupe-Hidalgo International Treaty. It gave the federal government ownership of 1,093 square feet of lands and riverbeds. Under the U.S. Constitution, it is illegal for governments to own more than 10 square miles that is only to be used for a capital. The Trans-Pecos pipeline has been strategically positioned to this crossing area of federal ownership, giving them control of the natural resources, as well as, the ability to charge international tariffs. The people of Mexico will tell you that their government is anticipating another war in the Middle East, like Syria, due to a water shortage and they want to be positioned in order to take advantage of the situation.

The message is regarding water, the source of life itself. A situation exist in Texas that is affecting the entire planet as a whole, and not for the common good of all. Most people are unaware that the Big Bend of Texas is home to the largest underground aquifer of the North American continent known as Phantom Cave. All artesian wells and springs are interconnected with this massive aquifer in West Texas which is the world's

capital of deep well fracking. Most people are also unaware that Texas has a massive fault line that runs across the state from San Angelo to Dallas, which is home to the Eagle Ford fracking operations. Please note that the infamous British Petroleum oil spill in the Gulf of Texas was a major tectonic plate fracture; a drilling lease executed by the federal government; an act that destroyed a way of life for millions of people, as well as, the marine and animal wildlife.

The federal government under the guise of the "Bureau of Reclamation" (BOR) has control of the water rights of Phantom Cave, as well as, San Solomon Spring. In 2011, the BOR put a claim on Phantom Cave stating their intentions were to protect a rare species of guppies. The State of Texas already protects the guppies at Balmorhea State Park, at San Solomon Spring. Government scientist have been unable to find the end to the vast caverns of "crystal clear" water in Phantom Cave, and a few have died trying.

The BOR has a long history in Texas. In 1939, Congress issued request for public assistance to water diversion programs for irrigation due to food shortages. The locals of Balmorhea did the work, but in 1941 after the war, local irrigators were presented with an arranged 40 year repayment plan they could not afford. Therefore, giving the BOR an opportunity to purchase the water rights.

Then came the Water Protection Act of 1974 that put financial demands on local water municipalities they could not meet. Water Municipalities operate by issuing bonds (debt) rather than by profit, which led to the "no worries" agenda of the BOR. They offered to take away the liabilities of the water act by the process of "quit-title" water right transfers. It is these same water diversion projects that have created the current day problems in California, as well as Colorado. It appears Texas is next on their list.

There is a more urgent matter at play six miles south of Colorado City, TX. Long ago, artesian wells called the "Seven Wells" were engulfed by the damming of Champion Creek by Texas Utility. Less than 25 miles north in Scurry County, local operators began in 1972, injecting Co2 into a large plateau called the SACROC (Scurry Area Canyon Reef Operators Committee). It later was consolidated and is still in operation today by a company named Kinder Morgan. The pressure at this site in a future specified point in time will elevate into a catastrophic event, contaminating the drinking water; a violation against the Clean Water Act of 1972.

There is more to this story than meets the eye, for it appears Kinder Morgan is working in partnership with the federal government to create this disastrous event in order to execute the Martial Law drill of Jade Helm. Being that I live in the Big Bend and am close to the Mexico border, I have noticed a huge increase of Border Patrol and Homeland Security agents who are driving unmarked vehicles without government license plates. Our train railways are full of military hardware and vehicles.
